TUITION FEES

Tuition Fees are charged per unit and vary according to the level of study.

Audit – Level 2 with no accreditation	\$200.00
Level 2 – diploma	\$400.00
Level 3 – degree	\$800.00
Level 4 – graduate diploma	\$850.00

Library and examination fees are all included in unit fees.

Text Books

Some units will require text books. This cost is not included in unit fees and students need to acquire them before classes commence.

FEE-HELP – Levels 3 and 4 only
